#### Managers view

---

The portfolio was launched in September 2017 and tracks the MMI Proprietary Mid and Small Cap Index. The index was specifically designed so that it completes the FTSE/JSE SWIX 40 Index, meaning that a correct combination of these two indices will have the same return as the FTSE/JSE SWIX All Share Index.

Net flows to and from the portfolio are matched with trades on a daily basis. It gets rebalanced on a quarterly basis in line with changes in its benchmark and portfolio holdings will mirror the index as close as practical to minimise the tracking error. The portfolio maintains a low cash weighting. The portfolio minimises trading costs and therefore uses futures as and when appropriate.

The constituent changes were the inclusion of Truworths, Reinet and Stor-Age as they entered the FTSE/JSE SWIX All Share Index while AngloGold, Amplats, Texton and Montauk exited the index.

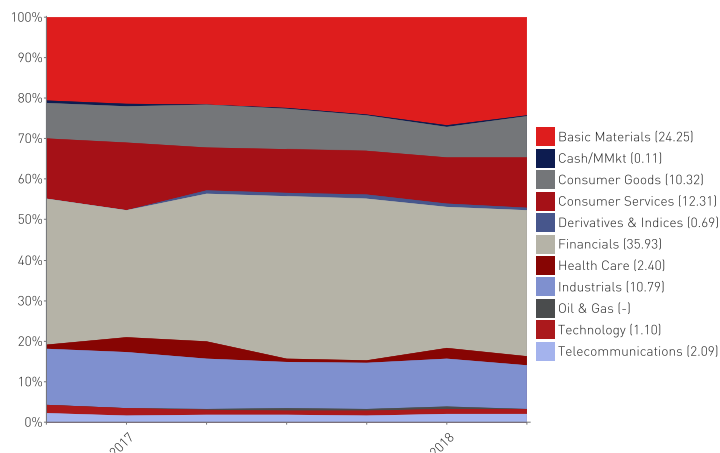
The MMI Proprietary Mid and Small Cap Index increased by 5.8% over the quarter. The assets in the portfolio grew by 89% during the quarter, largely due to cash inflows. The portfolio performance was marginally behind the benchmark due to flow related transaction costs.

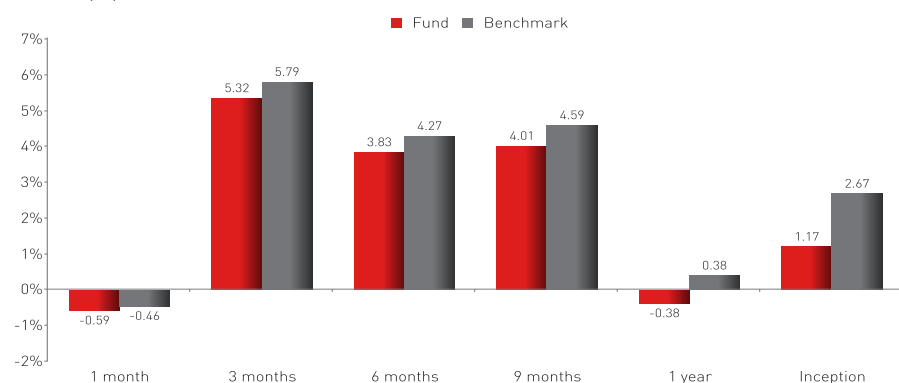
