Managers view

Portfolio overview

The fund ended the quarter with 81.4% hedged equity exposure, 2.3% in unhedged equity and 16.3% in cash.

Relative to the benchmark the fund has:

- A small overweight exposure to the resources sector. Within the sector we have an underweight exposure to the gold stocks and an overweight exposure to general mining stocks.
- A neutral exposure to the industrial sector. The fund has an overweight exposure to the retail sector.
- A neutral exposure to the financial sector. The fund has an overweight exposure to the life insurance sector.



Portfolio positioning

There were no constituent index changes which required rebalancing in the fund. The exposure to Prosus and Naspers were reduced while the exposure to Mr Price was increased.

The top five underweight exposures are:

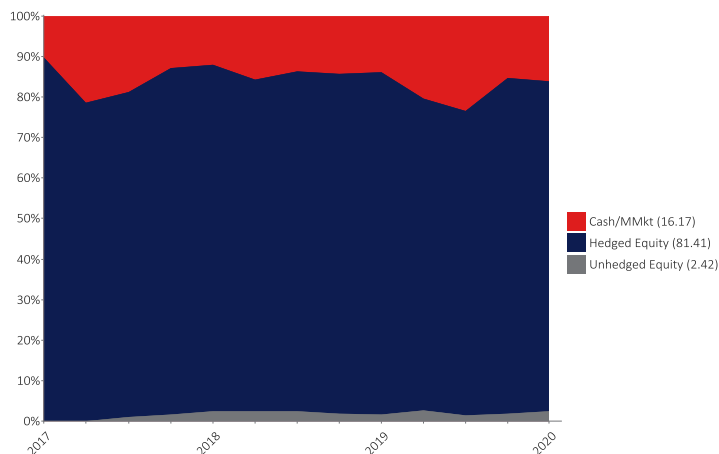

Portfolio (%)



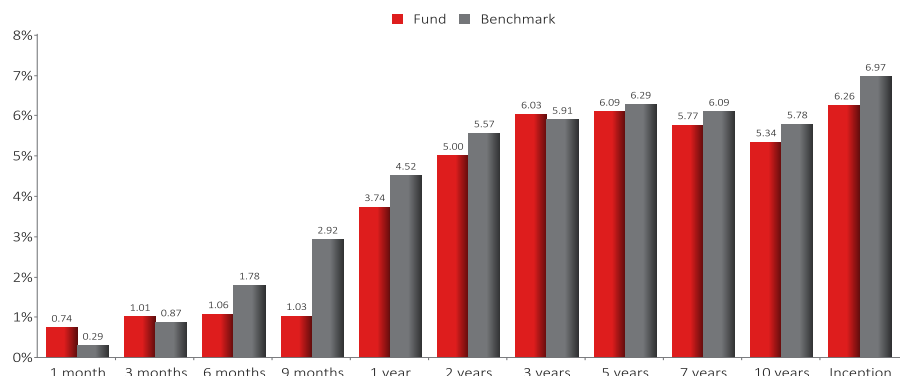

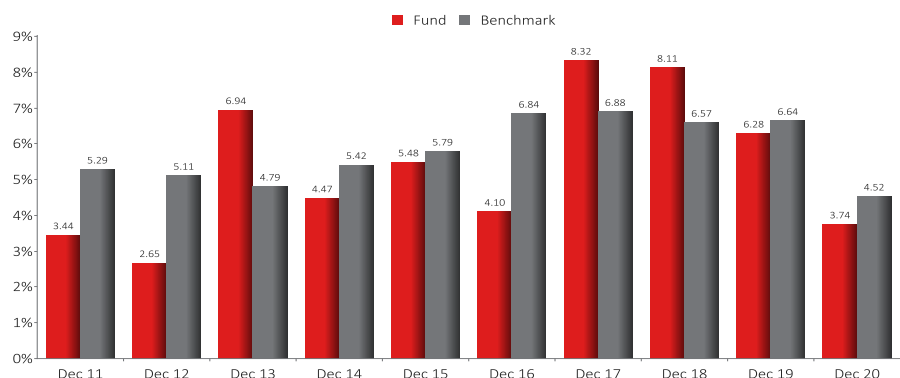
