Managers view

The portfolio is assertively positioned to have a material tilt towards shares that exhibit strong price and earnings momentum qualities.

At quarter-end the portfolio's equity exposure was 99.5%. It has an overweight position in the resources sector and an underweight position in the industrial sector, while it has a neutral exposure to the financial sector.

Within the resources sector the portfolio is overweight general mining and basic materials companies and within the industrial sector the portfolio is underweight telecommunication companies. Within the financial sector the portfolio is underweight diversified financial services and overweight banking shares.

The portfolio is concentrated in 29 stocks with the top 10 stocks forming 46.5% of the portfolio. These top 10 stocks are:

- Naspers 9.4%
- Sasol 5.6%
- Standard Bank 4.3%
- Richemont 3.9%
- Nedbank 3.9%
- Capitec 3.9%
- SANLAM 3.9%
- ABSA Group 3.9%
- Bidvest 3.9%
- Anglos 3.8%

During the quarter the portfolio sold Shoprite, The Foschini Group and Fortress REIT A while Amplats, Old Mutual and Sappi were added.

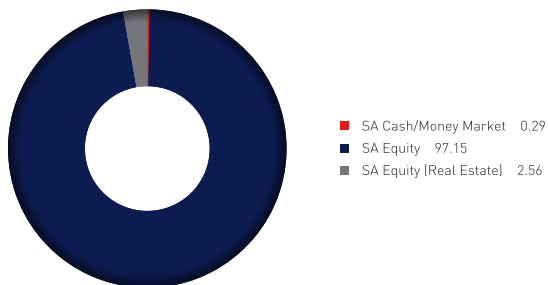

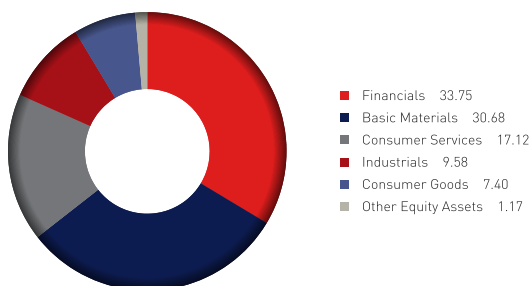

Equity allocation (%)

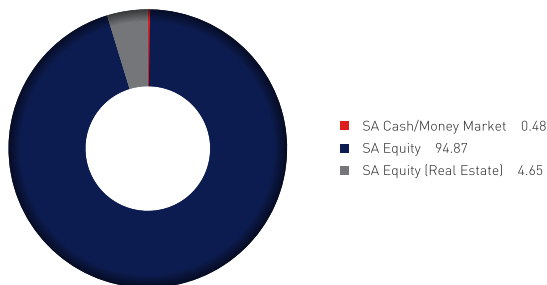

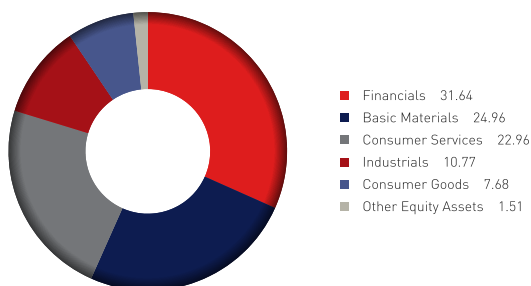

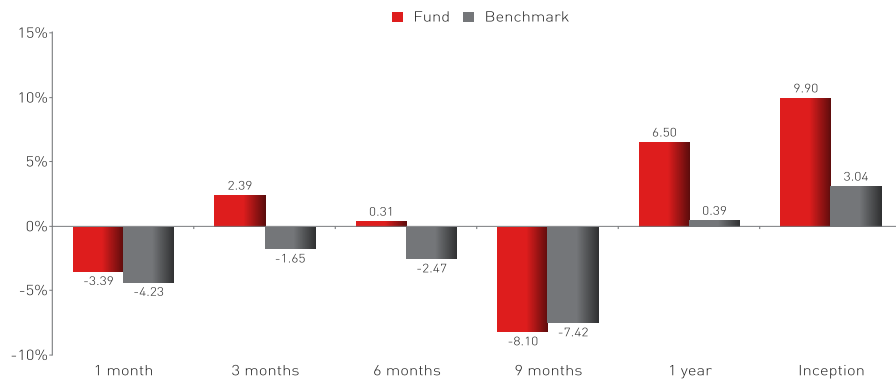
